Trump Administration Calls for Flat Funding for Passenger Rail

Advocates for improved passenger rail service have cause for cautious optimism following the release of the Trump Administration's fiscal year 2026 transportation budget request, which signals a continued commitment to the national Amtrak network.

The U.S. Department of Transportation (USDOT) <u>unveiled the proposal late</u> <u>last Friday</u>, which includes **\$2.427 billion for Amtrak operations** essentially the same levels of funding as in FY25 and FY24. While the purchasing power of that dollar amount has eroded due to inflation, it remains a dramatic improvement over calls to eliminate all Amtrak funding issued during the first Trump Administration.

The USDOT does call for a reallocation of resources between Amtrak's two operating accounts:

\$1.58 billion for Amtrak's National Network, an increase from \$1.29 billion in FY25

\$850 million for Amtrak's Northeast Corridor, down from \$1.14 billion in FY25

Amtrak hasn't issued a public statement in response to the budget proposal. Presumably, the railroad will be able to utilize increased ticket revenue to cover the reduction in federal assistance for NEC operations.

Other key rail and transit programs also saw flat funding or a slight reduction, including:

\$500 million for the Consolidated Rail Infrastructure and Safety Improvements (CRISI) Program, up from \$100 million in FY25;

Zero dollars for Federal-State Partnership for Intercity Passenger Rail (FSP) Program, same as FY25; and

\$2.21 billion for the Federal Transit Administration's Capital Investments Grant (CIG) Program, same as FY25.

The document also includes advanced funding for rail programs from the Infrastructure Investment and Jobs Act (IIJA) in tallying total budgetary resources, a positive indicator that the Trump Administration plans to move ahead with discretionary rail grants to states and local governments.

"This budget request indicates that the work advocates are doing is having an impact," said Jim Mathews, President & CEO of the Rail Passengers Association. "We are seeing a growing bipartisan recognition that rail is an important piece of the U.S. transportation network. With predictable investment, trains can provide Americans with a safer and more efficient travel alternative to congested roads and highways."

The U.S. House is scheduled to take up the Transportation, Housing and Urban Development (T-HUD) bill in early July, meaning negotiations could still alter funding levels before the bill becomes law. Nevertheless, for rail advocates, the White House budget proposal is a strong signal that we've

made progress in building a more durable political coalition.

"We encourage the House and Senate appropriators to build on the Trump Administration's budget proposal for passenger rail programs," said Mathews. "It's up to Congress to continue this positive momentum."

Californian Leaders Vow to Move Forward with HSR

California Democrats are organizing to defend the state's high-speed rail project following the Federal Railroad Administration's (FRA) June 4th announcement that it intends to revoke \$4 billion in federal grants. The FRA's decision cites delays, budget overruns, and concerns about the project's long-term sources of funding. However, Democratic leaders argue that the FRA's conclusions are misguided and fail to acknowledge the substantial progress that's been made.

In response to the FRA's announcement, the California High-Speed Rail Authority (CHSRA) defended its progress, noting that over 170 miles of track are under design and construction and that the project has already generated more than 15,300 jobs. CHSRA asserts that the FRA's assessment does not reflect the reality on the ground, which includes progress in several key areas, such as:

More than 52 structures and 69 miles of guideway complete on the initial 119-mile segment currently under construction between Madera, Fresno, Kings, and Tulare counties;

- 15,300 family wage construction jobs for residents, with over 97 percent being filled by Californians, and 70 percent going to residents of the Central Valley;

- 463 miles of the 494-mile San Francisco to Los Angeles/Anaheim highspeed rail system fully environmentally cleared and ready for construction;

- \$714 million provided by the Authority to help fund the successful Caltrain Electrification Project, which has led to a 40% increase in current ridership and paves the way for future high-speed rail blended service;

 \$76.7 million provided by the Authority to support the Rosecrans/Marquardt grade separation – a public safety enhancement addressing the most hazardous grade crossing in California which is already improving road safety and efficiency; and

- \$423 million contributed by the Authority towards Los Angeles Union Station's Link Union Station (Link US) Project to upgrade and transform the station into a world-class facility.

State Senator Scott Wiener—a leading voice in the state for passing policy reforms to make it easier to <u>build major transit projects</u>, <u>including high-speed rail</u>—vowed to keep fighting for the project, stating that California will not allow federal opposition to derail the project.

"We've seen this coming and we're going to do everything we can to prevent it," said Wiener, who Chairs the State Senate Budget Committee. "Regardless of what happens here, we're committed to making this project a reality."

Governor Gavin Newsom has <u>also recently reaffirmed</u> his commitment to support the project in May, emphasizing its importance for California's transportation future and environmental goals. The governor's budget which is currently before the California State Legislature—has proposed allocating at least \$1 billion annually from the state's cap-and-trade program to ensure the project's continuation.

Alstom's Upstate NY Plant 4 Opens

The small upstate community of Hornell, N.Y., celebrated a very big victory this week – ribbon-cutting at Alstom's Plant 4, which now stands as the most advanced railcar-building facility in North America.

The facility is heavily outfitted with state-of-the-art robotic welders and tooling to handle fully formed bilevel vehicles, and at peak output it will be capable of producing a new railcar every three days or so.

Alstom says that the car body manufacturing process involves welding together primary parts to create assemblies as long as 80 feet. At Plant 4, automated welding robots will be used to make sure tens of thousands of welds are precise within 1 millimeter, a feat made possible by incorporating Al technology so that the robots can work together safely, efficiently, and

accurately.

Alstom says transit authority customers will benefit from enhanced quality and lower cost of production. Chicago's Metra will be the first order to run through Plant 4.

This expansion at Alstom's Hornell site is expected to create 258 <u>new jobs</u>, including those in mechatronics engineering and robotics-related fields, while helping to retain 390 existing jobs.

"Hornell has long thrived as a hub for the railroad transportation industry, and our longstanding partnership with Alstom has played a vital role in that success," said Hornell Mayor John Buckley. "Alstom's continued investment in our city has not only created high-quality jobs and driven economic growth here in Hornell but has also delivered substantial benefits to the surrounding communities and the entire region. This collaboration strengthens Hornell's position as a leader in transportation innovation and manufacturing. We are deeply grateful to Governor Hochul and Alstom for their ongoing support and commitment to our community's future."

Suspension Looms For Unfunded Heartland Flyer

Amtrak is warning today that its Heartland Flyer service between Dallas-Fort Worth and Oklahoma City could evaporate by October 1 unless Texas can secure its share of the Flyer's funding.

TxDOT asked the legislature for \$7.05 million in this year's session to fund Flyer operations for the next two years, but the legislature didn't approve it. That leaves the Flyer in real jeopardy, and Amtrak has said that while it's working with "state and local partners" to find a way out of the problem, the service will have to be suspended absent that funding.

"Reliable rail service provides a vital transportation option for residents and visitors alike, strengthening regional mobility, economic development, and tourism," Amtrak President Roger Harris said in a prepared statement this afternoon. "With service that supports Texas' continued economic growth and the region's connectivity, sustaining the Heartland Flyer is essential to maintaining momentum and ensuring long term mobility in the region."

Amtrak estimates that the Heartland Flyer generates \$5.3 million in direct economic benefits and an estimated \$23.7 million in overall economic benefits to the two states served. The service also supports jobs that are at risk if funding is not restored.

Amtrak also notes that the Dallas-Fort Worth region is scheduled to host more 2026 World Cup soccer matches than any other U.S. city, making it even more important to keep the Heartland Flyer service in place for transporting fans and visitors from Oklahoma and beyond.

Your Association is working with regional advocacy partners on the best steps we can take together to keep the Flyer in service.
